DECISION OF THE COMPETITION OFFICE

According to the decision of IIHF's Hockey Operations Committee, after the investigation of on-line records, the Competition Office has made the conclusion, that team EHC Lions serially did not observe the Competition Regulations of U12 championship,

due to above reasons, team EHC Lions

**has been directly disqualified from Hungarian U12
championship and is obligated to pay the fine of 300 000
HUF + VAT**

JUSTIFICATION

According to the Competition Regulation of U12 championship:

"MINIMUM NUMBER OF PLAYERS AT THE START OF THE GAME:

Group „A”: 16+2,

Group „B”: 15+1,

Group „C”: 15+1"

Regarding playing rules, the regulation as follows:

“Player changes between the lines during the game are forbidden. The face-off must take place where the play has been stopped. The continuous use of 3 lines are obligatory.”

As EHC Lions arrived to each game with less players than required in the Competition Rules of U12 and the team serially violated the rules of U12 championship and created unclear situations on the games, the competition coordinator tried to draw the team's attention several times to observe the Competition Rules and on 19. October 2017 a Final Notice was sent to the club informing them about in case of the next anomaly the team will be disqualified.

On 29 October 2017 EHC Lions arrived to game U12 201 with 12+1 players.

The team is entitled to appeal according to 8.§ of IIHF Versenyszabályzat (http://www.jegkorongszovetseg.hu/upload/doclib/74/Versenyszabalyzat_2016_17_egyseges_szerk_161108.pdf).
