The League, the Hungarian Ice Hockey Association (hereinafter: MJSZ or Association) Sports Disciplinary Based on the authorization given in Section 12 (3) of its Regulations, in the sport of ice hockey, in particular with regard to the Erste League, Super Cup, Hungarian Cup, men's adult OB I. (hereinafter collectively: Leagues) in competition series, competitively by athletes, sports professionals and sports organizations

The Sports Disciplinary Regulations (hereinafter referred to as the Regulations) are set out as follows:

me.

§ 1 Scope of the Regulations

- (1) In the sport of ice hockey, especially in the League – in the League's competition rules, as specified in the competition regulations and other regulations – for athletes (in a competitive manner) hereinafter referred to as athletes).
- (2) In employment or contractual relationship with sports organizations participating in the League, or with the MJSZ or other legal sports professionals, especially coaches, departmental and team managers, competition judges, and referees (hereinafter collectively referred to as: sports professionals).

§ 2. Scope and competence

- (1) Athletes and sports professionals covered by the Regulations are subject to the following penalties: in the case of disciplinary matters (hereinafter: sports disciplinary matters), the Disciplinary Committee (hereinafter: Disciplinary Committee) is authorized to act.
- (2) Any action taken outside of League matches, or any action not specified in these rules or ethics The Disciplinary Committee of the MJSZ is authorized to act in disciplinary matters.
- (3) Against the decisions of the Disciplinary Committee, Section 71 (4) of the League's Competition Regulations There is no appeal against the decision of the Disciplinary Committee, they are announced can be executed immediately afterwards.
- (4) Disciplinary offenses under the jurisdiction of the League Disciplinary Committee, which are related to the competition or rules of the game, the International Ice Hockey Federation (hereinafter referred to as IIHF) or the Leagues seriously violates the rules of the game, or the rules of the tournament, league or cup series violates.
- (5) The Disciplinary Committee shall investigate all cases provided for in the Statutes of the MJSZ, the MJSZ It falls under the jurisdiction of the sports disciplinary regulations and the League's competition regulations.

§ 3 Disciplinary Committee

(1) According to Section 12 (3) of the Sports Disciplinary Regulations of the Hungarian Football Association, the Hungarian Football Association shall appoint its Disciplinary Committee delegates its election to the Leagues' decision-making body.

(2) The Disciplinary Committee shall establish its own rules of procedure.

(3) The composition of the Disciplinary Committee is contained in Annex 2 to these regulations.

(4) The Disciplinary Committee is assisted in its operational tasks by a secretary.

(5) Conflict of interest is regulated by Section 12 (7) of the MJSZ Sports Disciplinary Regulations.

(6) Any member of the Disciplinary Committee may request the Secretary of the Disciplinary Committee to exemption from participation in the proceedings, if this is done in connection with the person or sports organization subject to the proceedings relationship justifies it.

§ 4 Purpose of sports disciplinary punishment and disciplinary punishments

(1) The purpose of disciplinary punishment is to protect the order and purity of the sport of ice hockey – preventing the commission of a disciplinary offence by a participant in the competitive system of the sport, and educating those who commit disciplinary offenses to sportsmanship, and sanctioning the committed disciplinary offense.

(2) An athlete may be subject to a sports disciplinary penalty:

- a) verbal warning or written reprimand (expulsion or referee report)
not applicable in case of
- b) discounts granted by the MJSZ and/or the Leagues for a maximum period of one year
reduction, withdrawal;
- c) a one-match suspension – automatically – by the League
According to § 70 of the competition rules, if a player receives a Final Disciplinary penalty received within the last 5 minutes of regular time of the given match or in the eventual will automatically receive a one-match suspension at any time during overtime.
- In addition to the automatic ban, the case will always be reviewed by the Disciplinary Committee.

d) suspension from matches for a specified period, even permanently.

During the period of ineligibility, the athlete is subject to the following conditions:
may not play in any match of an organized league, cup or tournament series
to the field;

e) if the decision taken during the disciplinary proceedings so provides:

from international and official training matches, as well as national team events
prohibition;

f) a fine, the amount of which may not exceed the professional athlete's
six months of his average annual income from sports activities.

(3) No fine may be imposed on amateur and contracted amateur athletes. The fine shall be as follows:

may be imposed together with the disciplinary penalties specified in points d) and e);

(4) In the event of a criminal offence, the sanction applied during the court proceedings shall be applied in the same manner
No type of punishment can be imposed.

(5) The athlete shall be subject to disciplinary action under points c) and d) of paragraph (2).

It is not allowed in any other age group of the championship organized by the MJSZ.

(6) During League matches, the IIHF rules regarding sports disciplinary penalties, as well as

(7) Disciplinary penalties may be combined.

(8) Disciplinary sanctions may be applied to an athlete in combination. A disciplinary offence

5.§ Automatic penalty items

(1) The penalties that can be imposed on athletes in the event of disciplinary offenses are set out in Article 1.
included in the annex.

(2) The Disciplinary Committee shall use the criteria set out in Annex 1 when determining the Disciplinary Category.

§ 6 Decision-making process of the disciplinary committee

- (1) The decision-making process and structure of the Disciplinary Committee are described in Section 2 of these regulations. contained in Annex No.
- (2) The Disciplinary Committee shall automatically review only the decision that is based on the on-field judgment. or which is initiated by the person entitled to do so pursuant to Section 12(1).

§ 7 Irregularity constituting an accident

- (1) An accidental foul is one that is unintentionally caused by a player and he could neither avoid it nor influence its outcome.
- (2) The Disciplinary Committee issued a warning for an irregularity classified as an accident may sanction.

§ 8 Negligent irregularity

- (1) A careless foul is one that the player did not intentionally cause but could have avoided. or could have influenced its course and outcome.
- (2) In the event of negligent misconduct, the Disciplinary Committee shall consider as a mitigating circumstance: to take into account,
 - a) if the player made one or more moves to avoid the foul,
 - b) the party suffering the irregularity is not or not relevantly harmed;
- (3) In the event of negligent irregularity, the Disciplinary Committee shall consider as an aggravating circumstance: to take into account,
 - a) if the player does not make a move or does not make a move in the manner expected of him/her, the foul is committed to avoid,
 - b) if the offending party is injured;

§ 9 Intentional irregularity

- (1) A deliberate foul is one that the player prepared for and caused, assessed the outcome of and ignored its consequences.
- (2) Categories of intentional fouls:

- a) A foul committed in a sudden outburst, which the offending player does not commit in retaliation
 - committed with intent, a sudden irregularity committed against him, considered
 - triggered by an event;
- b) A foul committed in retaliation for a previous foul committed by the offending player.
 - an event triggered, which event is committed in retaliation;

(3) In the event of intentional misconduct, the Disciplinary Committee is obliged to compensate the innocent party for the injury. aggravating circumstances, and its absence should be considered as mitigating circumstances.

Section 10 Mitigation, aggravation, suspension of disciplinary punishment

- (1) When imposing a disciplinary penalty, both mitigating and aggravating circumstances shall be taken into account. to buy.
- (2) The degree of mitigation may not exceed the minimum penalty that can be imposed for the given irregularity. the amount of punishment.
- (3) The degree of aggravation may not exceed the maximum penalty that can be imposed for the given irregularity. one and a half times the amount of the penalty.
- (4) According to the provisions of Section 71 (5)-(7) of the League's competition regulations, disciplinary action may be aggravated. the punishment of the one who is a repeat offender.
- (5) The Disciplinary Committee may suspend the enforcement of the imposed disciplinary penalty for a maximum period of one year. may suspend, however, the period of suspension may not exceed the original term of the sentence the date of download.
- (6) The expiry of the period of suspension of the disciplinary penalty shall be considered as if the disciplinary penalty had been no penalty would have been imposed. § 11 Sports disciplinary procedure

- (1) Disciplinary proceedings may also be conducted if the athlete subject to disciplinary proceedings has a certificate, his/her employment, contractual or other relationship with the sports organization has ended in the meantime, or sports organization withdrew from the championship, tournament or cup series or was otherwise cancelled. This However, in such cases, only a disciplinary penalty may be imposed which is appropriate in the given case. applicable.

(2) Statements and evidentiary documents related to disciplinary proceedings shall be submitted to the

It should be sent to the Secretary of the Disciplinary Committee.

(3) The language of the disciplinary proceedings is Hungarian and English.

(4) The form of communication regarding disciplinary proceedings is email. Regarding the disciplinary matter

(5) The course of disciplinary proceedings is contained in Annex 2.

§ 12 Initiation of sports disciplinary proceedings

(1) Regarding incidents that occurred during League matches, disciplinary action will be taken until midnight on the day of the match.

may initiate proceedings:

a) the head of the League's Referee Working Group;

b) any member of the Disciplinary Committee;

c) the professional vice-president of the MJSZ;

d) the head of the Competition Office;

e) the League Manager;

f) the Secretary General of the MJSZ;

g) the officials of the teams participating in the given match, as listed in Annex 4

(2) In cases not initiated ex officio, initiated after midnight on the day of the match

(3) Disciplinary proceedings may be initiated in writing by those entitled to initiate disciplinary proceedings.

§ 13 Sports disciplinary decision

(1) The Disciplinary Committee shall decide on the basis of the evidence available to it. The decision shall be made in a closed online or meeting, or after electronic consultation. The consultation participation is mandatory for the members of the committee, except for Section 3 (5) Only the members of the Disciplinary Committee and the secretary may attend the meeting. The deliberations are not public. After the deliberations are over, the decision made must be announced to the with data subjects in accordance with the provisions of Section 14.

(2) Regarding the content of the disciplinary decision, it is either terminating or imposing a disciplinary penalty. decision.

a) A termination decision must be made if:

- i) the established act does not constitute a disciplinary offence;
- ii) the commission of the act forming the basis of the proceedings has not been proven;
- iii) the guilt of the perpetrator cannot be established;
- iv) the disciplinary offence has become statute-barred;
- v. in view of the gravity of the disciplinary offence and all the circumstances of the case, even the even the mildest disciplinary punishment does not seem necessary;
- vi. the person subject to the disciplinary proceedings dies during the disciplinary proceedings.

b) In cases not specified in paragraph a), a decision imposing a disciplinary penalty must be brought.

(3) The disciplinary decision consists of an introductory and operative part, a brief justification, a date and consists of a signature.

(4) The operative part of the termination decision must include the reasons for the disciplinary procedure. name of the person and data used to identify him/her. (5) The justification for a disciplinary decision imposing a sports disciplinary penalty must include: the facts considered proven, indicating the evidence, and explaining that the What disciplinary offense does the committed act constitute, for which the disciplinary the person subject to the proceedings is found guilty, finally the assessment of mitigating and aggravating circumstances and the disciplinary justification of the level of punishment.

(6) The decision must contain the legal provisions on which it is based and the

§ 14. Communication, recording and correction of the Sports Disciplinary Decision, registration

(1) The Secretary of the Disciplinary Committee shall, within 1 hour of the disciplinary decision being made,
sends within:

- a) the sports organization employing the athlete subject to the proceedings;
- b) the members of the Disciplinary Committee;
- c) to the League press list;
- d) the League management;

(2) The disciplinary decision shall be published by the Secretary of the Disciplinary Committee on the Erste Liga website.

(3) The Disciplinary Committee acting on the decision it has made and announced or communicated by delivery
cannot change the decision, any possible typographical errors or administrative errors
however, it may correct the decisions at its own discretion, or amend the decisions to include any irrelevant information omitted by mistake.
can be supplemented in terms of parts.

(4) Disciplinary decisions are recorded by the Secretary of the Disciplinary Committee.

§ 15 Fines related to sports disciplinary suspension

(1) The financial penalties associated with the sports disciplinary ban are set out in Section 73 of the League Competition Regulations.

(2) The Disciplinary Committee may also impose a fine if the irregularity is only
a warning or a sanction has been imposed. In this case, the amount of the fine may not exceed
the 50 EUR.

(3) The fine imposed in the disciplinary decision or the fine specified in the Regulations
The costs must be paid to the MJSZ within 15 days of receipt of the invoice.
In case of payment by post or cash, the receipt confirming payment of the fine must be submitted to the
It must be sent to the Secretary of the Disciplinary Committee on the day of payment.

(4) If the athlete liable to a fine does not pay the fine by the prescribed deadline, pays, the Disciplinary Committee, based on the initiative of the League management, shall suspend the athlete from may ban him/her from sporting activities until the fine is paid or may impose a repeated fine, up to a maximum amount of 5 million forints.

§ 16 Entry into force of the disciplinary decision

The disciplinary decision becomes final and enforceable on that day.


- (1) In cases not regulated in the Regulations, the sports disciplinary rules of the Hungarian Sports Federation shall apply.

Annex 2 - Composition, operational and decision-making process of the Disciplinary Committee

1) The Disciplinary Committee consists of:

- a. From the Disciplinary Committee Board;
- b. The Chairman of the Disciplinary Committee;
- c. From the Secretary of the Disciplinary Committee;

2) The Disciplinary Committee Board (hereinafter: Board) At least three, but in any case

consists of an odd number of members. The members are approved by the MJSZ Presidency after prior approval by the League Board.

3) The Board shall, on the basis of the evidence presented to them by the Secretary of the Disciplinary Committee, decide on the matter to be discussed.

4) Board members may meet online, in person, or by email.
they can discuss the case.

5) The members of the Board shall send the case classification report to the Secretary of the Commission in electronic form.



(2) The form of communication regarding disciplinary procedures is email. Regarding the case

Letters sent shall be deemed to have been delivered on the date of the same day. The body conducting the disciplinary proceedings communication is made to the club employing the player subject to the proceedings, who is responsible for forwarding communication to the accused party and providing them with full information about the proceedings.

(1) Pursuant to Section 12 (1) g) of these regulations, disciplinary proceedings may be initiated through their official representatives. the participating teams can initiate.

(2) An official representative of a participating team may only take disciplinary action regarding his/her own match. can initiate a relationship.

(3) Sports disciplinary proceedings must be initiated by the official team representative no later than midnight on the day of the match. can take the initiative.

(4) The procedural fee for initiating disciplinary proceedings is EUR 200, which must be paid to the account of the MJSZ. pay when initiating disciplinary proceedings.

(5) The official shall notify the Secretary of the Disciplinary Committee electronically (email) of the initiating a procedure, during which

a) forwards in an attachment the payment of the procedural fee specified in paragraph (5)

c) provides written justification by submitting a disciplinary procedure initiation form,

b) in the event of a disciplinary decision upholding a decision made on the field, the MJSZ shall keep records and issues an invoice to the initiating sports club.
