Privacy Policy

For the purpose of data processing in connection with contracts involving personal contribution concluded with the Hungarian Ice Hockey Federation

3. Nature of data processing

This Privacy Policy describes the processing of personal data of contractors or natural persons (hereinafter referred to as "Data Subjects") involved in business and assignment contracts (hereinafter referred to as "Contracts") concluded by HIHF as well as the use of private cars in connection with their activities.

4. Legal basis, purpose of processing, data retention period

Data processing by HIHF is based on Articles 6(1)(b) and 9(2)(b) of Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: GDPR), given that the processing is necessary for the conclusion of a contract.

4.1 Purpose of data processing:

Preparation, conclusion and execution of a contract.

4.2 Scope of personal data processed in connection with the contract:

- Name, place and date of birth, mother's name, address,
- tax identification number, tax number, social security number, bank account number,
- telephone number, e-mail address,
- remuneration/fee, signature.

Duration of data processing: five years after the insured person reaches the retirement age, on the basis of Act LXXXI of 1997 on Social Security Pension Benefits.

4.3 Data processed in connection with the declaration of personal, family benefits:

- Name, disclosure of disability, effective date of disability, whether the disability is permanent.
- Name, tax identification number, signature, name and tax identification number of dependent; name and tax identification number of eligible individual spouse/partner claiming family benefits; name and tax identification number of the paying agent who made tax deposit.

Duration of data processing: five years after the insured person reaches the retirement age, on the basis of Act LXXXI of 1997 on Social Security Pension Benefits.

4.4 Data processed in connection with vehicle use, fuel cost accounting:

- Name, place and date of birth, mother's name,
- address, tax identification number, vehicle registration number, signature,
- in the case of a non-owner, name, mother's name, place of birth, signature, og the owner authorising use of the vehicle,
- presentation of the documentation proving the ownership of the motor vehicle in accordance with Act CXVII of 1995 on Personal Income Tax, Annex 3, point IV. 9.

Duration of data processing: 8 years after the termination of the contractual relationship, on the basis of Act C of 2000 on Accounting.

5. Data subjects' rights in relation to data processing

5.1 Right of access

The data subject has the right to obtain from the HIHF, using the contact details provided in points 1 and 2., to be informed whether or not his or her personal data are being processed and, if such processing is taking place, to be informed that the HIHF:

- which personal data,
- on what legal basis,
- for what purposes,
- for how long; and
- to whom, when, pursuant to which law, to which personal data, to whom HIHF has granted access or to whom HIHF has transferred personal data;
- the source of personal data;
- whether the HIHF uses automated decision-making and its logic, including profiling.

The HIHF will provide a copy of the personal data processed free of charge for the first time upon the data subject's request, and may charge a reasonable fee based on administrative costs thereafter. In order to ensure data security and to protect the rights of the data subject, the HIHF is obliged to verify the identity of the data subject and of the person who wishes to exercise his/her right of access, and to this end, the provision of information, access to or copying of the data is subject to the identification of the data subject.

5.2 Right to rectification

The data subject may request the HIHF to amend any of his or her personal data using the contact details provided in points 1 and 2. If the data subject can credibly demonstrate the accuracy of the corrected data.

5.3 Right to restrict processing

The data subject may request, through the contact details provided in points 1 and 2, that the HIHF restricts the processing of his or her personal data (by clearly indicating the restriction of processing and ensuring that it is kept separate from other data) if:

 disputes the accuracy of his/her personal data (in this case, HIHF will limit the processing for the time it takes to verify the accuracy of the personal data)

- the processing is unlawful and the data subject opposes the erasure of the data and requests access restrictions instead,
- the controller no longer needs the personal data for the purposes of the processing but the data subject requires them for the establishment, exercise or defence of legal claims,
- the data subject has objected to the processing (in which case the restriction applies for a period of time until it is established whether the legitimate grounds of the controller prevail over the legitimate grounds of the data subject).

5.4 Right to object

The legal basis for the processing conceptually excludes the possibility.

5.5 Right to erasure

The data subject may request the erasure of his or her personal data if:

- the HIHF no longer needs it for the purposes for which it was collected or otherwise managed,
- the data subject withdraws his or her consent and there is no other legal basis for the processing,
- the data subject objects to the processing and there are no overriding legitimate grounds for the processing,
- - where the personal data have been unlawfully processed,
- where the personal data must be erased in order to comply with a legal obligation to which the HIHF is subject,
- - where the personal data have been collected in connection with the provision of information society services

In each case, we will investigate the complaint and do everything possible to handle it properly. The HIHF will comply with the data subject's request to exercise their rights within thirty days of the request. Depending on the number and complexity of the requests received, this time limit may be extended by a further two months, and the HIHF will inform the data subject of the reasons within one month.
